Privacy Notice

Dear Madam, Dear Sir,

in accordance with Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation – “**GDPR**”), we hereby provide you with information relating to the processing of your personal data.

1. Controller

1.1 The controller of your personal data shall be **BRM AERO, s.r.o.**, company ID No.: 291 90 924, registered office Letecká č.ev. 255, 686 04 Kunovice, Czech Republic, registered in the Commercial Register kept at the Regional Court in Brno under file No. C 64441 (“**Controller**”).

- 1.3 The Controller has not appointed a data protection officer.
2. Purposes of the processing, legal basis for the processing and recipients of personal data
- 2.1 The purpose of the processing of your personal data (name, surname, photos, video) is the promoting and presenting the Controller and its business. The legal basis for this processing is the consent given by you pursuant to Article 6(1)(a) GDPR (see (A) above). Your personal data will be processed by the Controller primarily by its own employees or agents or shared with the Controller's processors. The Controller will never transfer your personal data to countries outside the European Union or the European Economic Area or to international organisations.
- 2.2 The purpose of the processing of your contact data is to develop the Controller's business by transferring your contact data to the Controller's distributor. The legal basis for this processing is the consent given by you pursuant to Article 6(1)(a) GDPR (see (B) above). Your personal data will be processed by the Controller primarily by its own employees or agents or shared with the Controller's processors. Your personal data may also be transferred to countries outside the European Union or the European Economic Area if the distributor to whom your personal data is transferred is located there. Exceptionally, this may include countries that do not provide adequate protection of personal data, to which the Controller hereby expressly draws attention
3. Storage period
- 3.1 For the above purposes, the Controller will keep your personal data until your consent to processing is withdrawn.
4. Your rights
- 4.1 You have the right to withdraw your consent to the processing of your personal data at any time. Withdrawal of your consent will not affect the lawfulness of the processing of personal data based on this consent prior to its withdrawal.
- 4.2 You also have the right to request access to your personal data from the Controller, i.e. the right to obtain confirmation from the Controller as to whether or not your personal data is being processed and, if so, the right to access your personal data and other specified information. You also have the right to have inaccurate personal data corrected or incomplete personal data completed.
- 4.3 If any of the grounds listed in Article 17(1) GDPR are applied and none of the conditions listed in Article 17(3) GDPR are met, you have the right to have your personal data erased.
- 4.4 If the case referred to in Article 18(1) GDPR occurs, you have the right to restrict the processing of your personal data.
- 4.5 You may exercise all of the rights set out herein by contacting the Controller as set out in clause 1.2 of this document.
- 4.6 If you believe that the processing of your personal data has infringed the GDPR, you have the right to lodge a complaint with a supervisory authority, in particular in the country of your habitual residence, place of your work or place of the alleged infringement. This supervisory authority for the Czech Republic is the Office for Personal Data Protection, located at Pplk.
